GCSE (9-1) Modern Foreign Language qualifications discontinuation

As announced in April 2024, the difficult decision has been made to **discontinue** our suite of Modern Foreign Language GCSE (9-1) MFL qualifications in French, German and Spanish. The final assessment opportunity for these specifications will be Summer 2025. Our AS and A level suite of MFL qualifications, however, will remain in place for the future.

Speaking window dates for 2025

The speaking window for both GCE and GCSE will run from Tuesday 1st April – Tuesday 6th May 2025. Please note that these dates include the Easter break.

Important reminder for speaking assessments: MFL Centre Forms and Allocation of Set Lists

Whether you are a teacher-examiner or have a visiting examiner to conduct the speaking assessments, please remember to complete <u>all paperwork</u> for upload to the Surpass system:

- for GCSE; the MFL Centre Form and the Allocation of Set List
- for AS/A level; the MFL Centre Form

The paperwork covers the authentication of candidates' work, GDPR requirements, and a record of any extra-time (officially granted). It also allows examiners to check which examining materials were issued and used for each candidate. This information is vital for the smooth running and marking of the speaking assessment.
